Amelia was taken to a hospital due to injuries & trouble breathing. She is being treated for a fractured hand & other wounds. Please pray for Roper, Amelia & their ministry as they continue to face challenges while serving the Lord. (Roper is a friend of Dennis Olsen who met him through the Alliance Prayer Team.)
